#### From the President

(At ACA's Annual Business Meeting in Birmingham, Jane Nokes succeeded Lee Miller as President of the Academy of Certified Archivists. Below is an excerpt from Jane's presidential address — Editor)

I would like to begin by thanking Lee Miller for being an extraordinary example of leadership in action. His vision for the Academy and his determination to turn that vision into real achievements are laudatory. From the website to cross-advertising, to facing down the naysayers on the various listservs Lee has accomplished so much for the Academy and, by extension, the whole archival profession. His dedication is matched by a delightful wit and unfailing civility. Lee, from a Northern fan to a Southern gentleman, a simple but heartfelt thank you.

For those who do not know me, my name is Jane Nokes and I'll be your President this year. In addition to various roles in SAA, from chairing the Business Archives Section and serving on the ART Task Force for Carolyn Geda and the inimitable and much missed Harold Naugler to serving on the Editorial Board of *The American Archivist*. I was President of the Association of Canadian Archivists (the other ACA as we call it) and the founding Chairperson of the Toronto Area Archivists Group.

I am the Director of Archives and Fine Art for the Scotiabank Group, operating two wide-ranging portfolios with a full time staff of 5 plus 4 contract positions. Scotiabank Group operates in 51 countries with a staff of 50,000. The Fine Art collection is one of the leading corporate art collections in Canada. This past year my colleague Matt Szybalski was Vice President of the Association of Canadian Archivists—meaning there were 2 ACA Vice Presidents in one office!

I am thrilled to be your incoming President. In concert with the quite formidable members of the Board of Regents, Committees, and Task Forces, I am committed to taking the Academy forward. Our most important role in the coming year is to be a confident voice to lobby for change and to provide leadership on the issues we face collectively. I love our profession and am convinced that the Academy represents the apex of talent and commitment in our profession.

Internally, your leadership has moved confidently and competently through a landmark year of a bumper crop of founding members' re-certifications (thanks Judith Cetina and company!) and a record breaking number of exam applicants to the establishment of the Role Delineation Task Force and the Re-Certification Guidelines Task Force. Both of these new task forces are designed to let people know that we keep them up to date. This year, working with the SAA leadership, we added re-certification points as a stated benefit of SAA continuing education programs. In addition Peter Hirtle has asked us to continue to work with SAA on new initiatives.

Our representation at all regional archival association meetings is established and will be enhanced this year with a traveling display unit. The Association of Canadian Archivists met in Vancouver in 2002, with delegates' briefcases sponsored by Scotiabank and stuffed with Academy brochures. The ACA's annual meeting will be in Toronto in June 2003, and I am determined that Toronto will be a site for the certification exam next August. Lee Miller and I will host an information session on the Academy at the Society of Southwest Archivists in New Orleans in May. On the assumption that Outreach is critical to our continued growth and success, Lee has agreed to continue updating the website and supplying items to the listservs and a list of newsletter editors.

Other initiatives this year included a writing to Human Resources consultants, enclosing the two brochures, "In Service to the Profession" and "An Employer's Guide to Archival Certification," which was reproduced in the *ACA News*. As you are no doubt aware, most of our parent organizations rely on a finite list of H.R. consultants when hiring and setting job levels for archivists. Next year, with Beth Bensman, I would like to follow up on this initiative with an expanded writing to H.R. departments and major archival institutions (those who are celebrated for 50 years membership in SAA, for example), reminding them that certification provides employers with a measure of an individual archivist's level of competence and commitment.

A recent book by philosopher Thomas de Koninok, a Laval University professor, entitled *The New Ignorance and the Problem of Culture*, is fascinating on its own and instructive in our context. De Koninok's main thrust is that today's technology and easy access to information have furthered the idea that we know everything—a "confining and deadly illusion" for individuals and for society. Archivists are by our nature and our training in the business of dispelling illusions. The Academy's strength is that it brings rational, articulate, and critical debate to the archival profession. The archival profession's strength is that it counters the increasingly abstract world in which the communications media circulates images rather than ideas. Archival practitioners, and especially certified archivists, undertake arguably one of the hardest things in the world to do: to challenge ourselves, to question ourselves, and the society we live in, and in so doing, become stronger contributors to our profession and society. I would ask each of you to make a contribution to the Academy in 2003. Bring in a new member, wear your CA lapel pins and invite interest in the Academy, write even a short notice or article for your parent organization's newsletter or an archival listsery, represent the Academy at regional archival association meetings, stand for office in one of our professional associations. For yourself, your career, the Academy, and our profession—it's a step in the right direction!

The enthusiasm and energy of our membership, who regularly put forward a roster of leaders which I frankly think is the envy of the profession, feeds my resolve to continue to work for the Academy to the best of my ability.

I welcome the new members of the Board, and with the Committees and the Task Forces' efforts to support us, resolve to take the Academy forward in 2003.

#### The Year in Review

2001/2002 was another successful year for the Academy. Last year we celebrated:

- · A record number of new members
- A record number of applicants
- A record number of persons taking the examination
- · A record number of examination sites
- A record number of persons attending the Academy's annual luncheon
- A budget in the black and projected to stay that way

The Academy also undertook several new initiatives:

- We recognized founding members with "Charter Member" status and certificates of appreciation.
- Because of the many requests the Academy receives to recommend consultants, the Academy created a consultant referral service.
- The Academy created an "Archival Recertification Credit" program (ARC) that allows organizations to advertise the number of credits Academy members may receive for participating in workshops and meetings. This gives archival groups an additional way to promote their programs while allowing Certified Archivists to know exactly how many ARC points they will receive for their continuing education activities.
- A blue-ribbon task force led by Edie Hedlin was appointed to ensure the Role Delineation continues to accurately describe the archival profession.
- Reciprocal exchange advertisement agreements were reached with several organizations.
- To counter inaccurate information being circulated about archival certification, the Academy added a "Myths vs. Facts" document to its web page and distributed selections from it to archival listservs
- Began two campaigns to reach out to employers through sending information to human resources departments (led by Jane Nokes) and to employers who advertise on the archives listsery (led by Michael Bullington)

2001/2002 was a busy year for the Academy, but it was busy only because the Academy had a record of consistent success to build on.

### **ACA By The Numbers**

- 109 candidates sat for this year's certification exam, in 12 locations—both records for the Academy. 97 of those candidates took the exam for initial certification, 12 for certification maintenance, and 7 were re-taking the exam.
- As of the SAA meeting, 222 petitions for re-certification have been received. Of that number 136 petitions had been
  reviewed as of the SAA meeting, 71 were under review by the re-certification review teams, 44 were awaiting
  review, and 12 candidates chose to re-certify by exam (contact Judy Cetina if you have questions about the status
  of your petition).
- Steve Grandin, in the ACA Office, reports that, as of Birmingham, 700 out of 722 members had renewed their membership—a 97% renewal rate.

#### Item-Writing Workshop Held in Birmingham

The ACA sponsored a second annual Item-Writing Workshop on August 22 in Birmingham, AL. Certified archivists gathered to learn about the process of developing the certification exam and to write new questions for the item-bank from which the test is constructed.

Participants drafted questions according to a "Guide to Preparing Multiple-Choice Items" developed by educational testing professionals. Working from the ACA Role Delineation Statement, they linked each item to a particular domain, task statement, and knowledge statement; and provided to reference for the correct response from an authoritative source in the archival literature.

Bringing their draft questions to the workshop, which was directed by Anne P. Diffendal, Regent for Examination Development, they reviewed each, rejecting some and revising others to be considered for addition to the item-bank by the Examination Development Committee at its meeting in March.
